Diagnostic and Preventive Services - Used to diagnose and/or prevent dental abnormalities or disease (includes exams, cleanings and fluoride treatments)	100%	0%

Oral Surgery Services - Extractions and dental surgery, including preoperative and postoperative care	100%	0%
Endodontic Services - Used to treat teeth with diseased or damaged nerves (for example, root canals)	100%	0%

Relines and Repairs - Relines and repairs to bridges and dentures	100%	0%

Maximum Payment - \$1,200 per person total per benefit year on Class I, Class II and Class III Benefits.

Deductible - None.

Waiting Period - Employees who are eligible for dental benefits are covered on the first day of the month following the date of hire.

Eligible People - All principals and assistant principals of the contractor.

Also eligible are your legal spouse and your dependent children.

If you and your spouse are both eligible under this contract, you may be enrolled as both a subscriber on your own application card and as a dependent on your spouse's application card. Your dependent children may be enrolled on both application cards as well. Delta Dental will coordinate benefits. The Contractor pays the full cost of this plan.

Benefits will cease on the last day of the month in which the employee is terminated.
